### **3 YEAR GENETIC WARRANTY**

A Heart for Puppies, LLC certifies, to the best of our knowledge and ability, above dog/puppy is in sound health. The breeder commits to a 3 (three) year warranty, from purchase date, of any genetic defect(s) for above dog/puppy. Said dog/puppy is current on a vaccinations and worming protocol as stated on vaccination record provided to the Buyer(s). The Buyer(s) are responsible for further vaccinations and boosters.

The following stipulations must be adhered to in order for warranty to be in affect:

\*Puppy must remain on Royal Canine dog food\*

**A Heart For Puppies, LLC must be notified of any and all appointments, diagnosis and/or prognosis prior to any and all treatment(s), tests or therapies being administered.**

Official report(s) from 2 (two) unaffiliated, licensed veterinarians stating the above dog/puppy has a life threatening genetic defect which will cause a shortened life to the above dog/puppy; the report(s) must be sent to A Heart For Puppies, LLC with addresses and phone numbers of licensed veterinarians.

\*In the event of death, an autopsy MUST BE DONE by a licensed veterinarian to determine cause of death. The documentation must be forwarded to A Heart For Puppies, LLC before a determination of replacement, refund or reimbursement, will be made.

\*Breeder reserves the right for a second opinion by a licensed veterinarian of breeder's choice, at breeder's expense.

The breeder reserves the right to confirm diagnosis of above dog/puppy with a licensed veterinarian of their choice. Breeder **will NOT** be responsible for any expense(s) the Buyer(s) may incur, including shipping and veterinarian expenses concerning above dog/puppy, after completed sale unless such expense is due to Genetic defect. Warranty applies only to the original Buyer(s) of dog/puppy for replacement, refund or credit of a future dog/puppy. This warranty is non transferable. **Breeder will be responsible for expense(s) incurred from illness/death as a result of Genetic Defect for UP TO 50% OF ORIGINAL PURCHASE AMOUNT PAID FOR PUPPY. Breeder is NOT responsible for injury, environmental issues or standard veterinarian care/visits.**

Breeders can not control, and will not warranty, the exposures or environment your new dog/puppy encounters after leaving our home on its journey to their forever home. Dog/Puppies can, at times, experience stress when moving to their new forever homes. Stress can be brought on due to change of environment, change of routine, the move/journey, change of diet, excessive handling, not enough quiet time, or not eating properly. These stresses can cause issues such as, but not limited to: loss of appetite, colds, hypoglycemia, coccidia (coccidiosis), and/or giardia (giardiasis). These conditions are treatable and do not warrant a replacement or refund of dog/puppy.

**If puppy is seen/inspected by a licensed veterinarian within 5 days of leaving our premises, A Heart For Puppies, LLC will cover treatment costs associated with a giardia and/or Coccidia up to \$200 (two-hundred dollars)**

. A HEART FOR PUPPIES, LLC WARRANTY DOES NOT COVER:

\*Internal parasites, such as intestinal worms, giardia, coccidia and many others, are very common. Though we are on a continued protocol of de-worming, it only takes a brief encounter for a puppy to contract any one or more of these parasites as the immune system is not at full strength. A simple walk on a sidewalk or in a park can infect your new puppy

\*A Heart For Puppies, LLC DOES require Buyer(s) spay or neuter above dog/puppy within six (6) months of puppy coming home. It is out of care and concern of unwanted and/or accidental pregnancies that we require our puppies be spayed or neutered.

It is you (the Buyer/s) ultimate responsibility to provide love and care for your dog/puppy (adequate food, water, shelter, and veterinary care, etc...)

Please be aware as a new dog/puppy owner, you share in the responsibility to help prevent hip dysplasia and luxating patellas, as these issues are not only a hereditary issue, but can be environmental; jumping from high places, up and down stairs, etc... Through proper diet, proper exercise, and quality living conditions, you will play the primary role in the growth and development of your new puppy.
